Minutes of Last Meeting

Re the Club Voice:

- We need to give more time for clubs to voice their concerns/questions. Each Director to give brief introduction to their responsibilities only
- How do we get more clubs engaged in the meetings as a number of clubs did not attend.

Actions

6. Directors to send Chair nominations for possible President Elect by Sunday 21st December.

Additional Points

Chris informed the group that Cup Final dates would need to change due to postponed league games.

Chris is looking for additional funding to support the development of Transition Festivals

Graeme highlighted the excellent work Chris Ward is doing within the Rugby Safe remit.

Discipline is very busy at the moment. There have been some concerns from the Plymouth Referee Society re Panel decisions. Graeme to discuss possible session with their Chair.

Kit for three County Championship sides have been ordered and will use the same sponsors from last season.

Under 18 boys finish their series of games with an away trip to Cornwall (since switched to Ivybridge due to weather conditions). The Under 16 girls have won three, lost three and drawn one (v Gloucestershire).

Under 20s trials will be on Sunday 18th January at Ashbury.

Tamar Cup will be held at Plymouth Albion on Easter Saturday. County Championship home fixture venues are being planned by the two Team Managers.

Keish highlighted the increased visibility of the Women's Game with clubs driving content. Website has been updated.

Keish discussed cup competitions as a way of creating more game time and will develop a proposal for cup and shield competitions. A possible approach might be festivals this year and full competition next. Chris will work with Keish on this.

Nicola discussed a Women's World Cup trophy tour in the new year (details to follow) and that the CB can send two representatives to a meeting with Steve Grainger on the 21st April in Torquay.
